152/04/15 Chairman's Opening address:

The Chairman welcomed all to the meeting.

153/04/15 Minutes

A couple of amendments needed to be made –correct figure needed inserting for the Village Hall and the date needed changing.

The notes were accepted as a true and accurate record and proposed by Cllr G Bailey and seconded by Cllr Everard.

154/04/15 Declarations of Interest

Cllr R Wright declared an interest in the planning application for 102 Main Street.

155/04/15 Feedback on action points;

- Training courses-the clerk confirmed that Cllr Everard has been booked on a training course for new Councillors at Kirton on 24th June.
- LRSP-the Chairman informed the meeting that the reactive signs had been delivered and fixed at Burdens and near to Cllr Panton's. The data showed that over five days, including Good Friday, 22,000 vehicles passed through North Kyme of which 60% were doing over 30 mph. The Chairman also informed the meeting that he would liaise with South Kyme regarding the rotation of the signs.
- Defibrillator- Cllr R Wright reported back on the cost which was approximately £2,000 + Vat. After some discussion, the Chairman said he would speak to Carol at Billingham for further information.
