18/06/11 Chairman's Opening address:

The Chairman welcomed Councillor Yeomans to the Council and apologised for the lack of invitation to the meeting in May. The Chairman also reported that he was really pleased with the progress made in the village.

19/06/11 Minutes

The minutes of the previous meeting were agreed as a true and accurate record and proposed by Cllr T Carroll and seconded by Cllr G Bailey.

20/06/11 Declarations of Interest

No declarations of interest were declared.

21/06//11 Feedback on action points

- Parish Flower Tubs-New tubs had been constructed by Mr S Colclough, since the last meeting for which as yet, no invoices had been received. Ann and Steve Colclough along with Matthew and Tricia were thanked for their efforts. Two parishioners have taken responsibility for watering the tubs.
- Parish Notice board-two quotes have been received. The Councillors discussed the requirements for the new notice board. The preferred quote is the Pelican Trust quote but the Councillors felt the price was still too high. Action: clerk asked to contact and see if the price can be lowered.
- Village Gateway signs-Cllr G Panton informed the meeting that the Gateway signs had been erected without any problems. The sign on Anwick Fen is a little obscured at the moment due to its location. The Chairman thanked Cllr Panton for organising the refurbishment. Mr J Harrison was also thanked for helping Cllr Panton. Action: Clerk to send out invoices to the five companies who feature on the signs of £65 + vat.
- **Anglian Water-**the clerk reported that she had phoned and spoken to Anglian Water who were contacting the Parishioner direct to see if the issue can be resolved.

22/06/11 Financial Report

The clerk reported the current financial position and a number of receipts had been passed to the clerk for approval by the Council;

A vote was taken and Ms Mayhew received 4 votes and Mr Brittain 2 votes so Ms Mayhew was co-opted as Parish Councillor.

The clerk had distributed information relating to the abolition of the Standards Board and she asked District Councillor Powell to comment. The basics are that Parish Councils will have no governance from above.

28/06/11 Playing Field –naming ceremony

The date for this has been fixed-Saturday 23rd July between 2-5 p.m. The Chairman reported that he had spoken to Mrs D Goddard who has expressed a wish make a donation towards the event. The suggestion was made as to whether the event could feature a Falconry display. A plaque also needs to be bought and inscribed with a suitable tribute to Cllr J Goddard.

It was suggested that a contribution from North Kyme Parish Council should be made of £200 towards the event.
