A cheque was handed to the Chairman of the Village Hall Committee (Mr J Goddard) for the sum of £24,147.30 made out in the name of, North Kyme Village Hall New Project Account. This money is to will be used in aiding capital works, and towards applications for further funding for the building of a new Village Hall on the playing field site on Vacherie Lane, in accordance to the wishes of the Parish as a whole.

The clerk is to look into the cost of having the playing field insured with the Allianz, the present holder of the Parish insurance scheme. If this is too costly then she is to contact the Community Council to ask their cover costs. The field will at present hold no other equipment other than goal posts.

The Parish Council will hold in the Lloyds TSB account the remaining £720.47 and any tax that maybe due, to pay any other expenditure appertaining to this project such as the solicitors fees of £1,349.99.
