**15/07/09 Chairman's Opening address:**

Chair welcomed all to the meeting. Policeman has been asked to attend but was unable to do so.

**16/05/09 Minutes**

Clerk's notes agreed as a true and accurate record. Chair signed and placed in minute book. Proposed by Cllr T Handley and seconded by Cllr G Bailey.

**17/07/09 Feedback on action points:**

- Mobile Post Office- Chair reported that the issue has been raised at the Cluster Meeting in April and further information may be available at the next Cluster meeting on July 13<sup>th</sup>.
- Goal posts-Chair reported that he had received some quotes and the costs were high-£560 per pair. Other suggestions were made but health and safety requirements need to be adhered to therefore it was decided that a reputable company needed to be used. Cllr R Wood and Cllr G Panton mentioned a possible source of funding from the North Kyme Panthers. **Action:** Cllr Panton will investigate and report back. Cllr Panton also suggested that the young people of the village take some responsibility for the funding of the goal posts. **Action:** The Chair will speak to Mr Grice regarding this.
- Highways-clerk reported that lighting and footpaths had been reported to NKDC. A map has been sent for us to indicate where lighting concerns are. This was completed by the clerk.

The clerk also brought to the attention of the meeting a notification of county matter planning application regarding the redevelopment of the former school site. District Councillor Powell addressed the meeting regarding this and informed the Council that the Planning Committee was to meet next week.

### **19/07/09 Financial Report.**

Clerk presented an invoice for the hire of the village hall £80.00. Payment proposed by Cllr G Panton and seconded by Cllr G Bailey.

Clerk explained that all the paper work was with Lloyds to change the bank mandate and Cllr Panton had been to collect a new cheque book but unfortunately this had not arrived. No cheques can be issued until a new cheque book arrives.

The clerk asked that her salary be paid in one lump sum to ensure it was paid within the financial year. Councillors discussed and unanimously agreed to pay it in September each year.

### **20/07/09 Village Walk**

The clerk reminded councillors that this will take place on Thursday 16<sup>th</sup> July at 10.00a.m. The following points were raised as being of concern; man holes along the main road, sinks on the side of the roads, drainage outside no.34, accident spot on the corner near Burdens.

- Chair informed councillors of the progress with the new village hall build. No letter has been received from NKDC to confirm the £25,000 match funding has been granted. Cllr R Wood asked about the roadway and the Chair
